What is covered in the courses? And what regulations are these courses in line with?

WA: Our Safer Gambling training is best-in-class training specifically created for UK land-based and online gaming company employees. The training balances compliance, player protection and commercial objectives to ensure that the gaming industry is safe, sustainable and fun.

How did you set about creating the courses?

How did the partnership with Better Change come about?
